## CEASE OF TRADE AND NEW WELKOM YIZANI TRADING PLATFORM

---

As you know the Registrar of Security Services previously requested that Welkom Yizani brings its affairs in line with the Financial Markets Act, 2012 (the FM Act). In line with this directive, Welkom Yizani's shares will be listed on the exchange operated by Equity Express Securities Exchange Proprietary Limited (**ESEE**). ESEE is a licensed exchange authorised in accordance with the terms of the FM Act to operate as such.

Shareholders will not be able to buy or sell Welkom Yizani shares between **09:00** on **19 November 2018** and **17:00** on **22 November 2018**. This is to facilitate the listing of the Welkom Yizani shares currently trading on the over-the-counter (**OTC**) trading platform operated by Singular Systems Proprietary Limited to the exchange operated by ESEE.

From **09:00** on **23 November 2018**, the Welkom Yizani shares will be listed on ESEE and shareholders will be trading their shares through ESEE. The trading process on the ESEE exchange will be very similar to trading on the current OTC trading platform.

- If you use the Welkom Yizani call centre to buy or sell your shares, that will not change – you will still use the same call centre on 0860 12 12 24.
- If you use the website to buy or sell shares, you will be able to access the ESEE trading platform from the Welkom Yizani website: [www.welkomyizani.co.za](http://www.welkomyizani.co.za) or you may go directly to the ESEE website: [www.eese.co.za](http://www.eese.co.za).
- If you use the Welkom Yizani walk-in centre to buy or sell your shares, that will not change – you can still go to the same address at 25 Scott Street, Waverley, Johannesburg.

To resume trading in WY shares listed on ESEE you will, however, among other things, be required to accept ESEE's terms and conditions as well as enter into a broker mandate with Singular.
